

Declaration Form for International Students Participating in the Exchange Program of National Chengchi University

I, _____, hereby declare my intent to participate in the exchange program to National Chengchi University (NCCU). By signing this document, I acknowledge and agree to the following terms and conditions regarding my participation in the exchange program:

1. I agree to comply with the laws and regulations of the government of Taiwan and National Chengchi University (NCCU or “the University”).
2. I acknowledge that my behavior during the exchange program reflects not only on myself but also on my home institution and country. I pledge to conduct myself with integrity, respect, and responsibility throughout the duration of the program.
3. If I engage in self-harm, commit suicide, or display behaviors that threaten or harm other people due to my psychological or mental health issues while staying in Taiwan, I agree to comply with professional counseling or hospitalization after being reviewed as mandatory in accordance with the standards stated in the Mental Health Act. If I fail to comply, I shall be responsible for the consequences.
4. I agree to never carry, use, or produce the items prohibited under the Narcotics Hazard Prevention Act, such as Heroin, cocaine, MDMA, opium, cannabis, stimulants, psychotropic substances and other narcotic drugs.
5. I agree to comply with the traffic rules and regulations in Taiwan. I will not operate a car, motorcycle, bicycle, or any other vehicle while under the influence of alcohol.
6. (Only for NCCU dormitory residents) I agree to comply with regulations governing the NCCU dormitory or NCCU-iHouse. In case of violation, I consent to receive admonition and disciplinary actions accordingly.
7. I understand that Office of International Cooperation of NCCU

(NCCUOIC) will notify my home institution and has a right to terminate my exchange program if the following situations occur:

- 7.1 I have a physical or mental health issue that prevent me from continue a smooth studying at NCCU.
 - 7.2 The University receives notification from the Taiwanese law enforcement agencies about my suspected violations against Taiwan laws.
 - 7.3 I have been reported to disrupt the classroom order, or to make a threat or insult directed at faculty members or fellow students, or involvement in physical altercations.
 - 7.4 Any other behavior causing severe damage to the reputation, finances, or other aspects of the University.
8. I understand that I can contact NCCUOIC for inquiries during my exchange period in the University.
 9. I agree to provide my contact information to NCCUOIC for them to contact me directly if needed.
 10. If I disrupt the class or course or cause any harm or damage (physically or mentally), I agree to follow NCCUOIC's instruction and withdraw from the course to prevent any further conflicts from occurring.
 11. I understand that failure to comply with any of the above terms may result in disciplinary action, up to and including termination of my exchange program.
